The company raised NCD only for Rs. 50 Crs, of which, two tranches of Rs. 10 Crs each have been redeemed as on March 31, 2017 and March 31, 2018 respectively and also tranch of Rs 8 crores have been redeemed on July 30, 2018. Accordingly, the rating stands valid only for an amount of Rs. 22 Crs.
